THIS AMENDMENT TO THE CONTRACT, entered into this 15th day of March, 2018, and effective immediately by and between EL PASO COUNTY EMERGENCY SERVICES AUTHORITY (ESA) and AMERICAN MEDICAL RESPONSE OF COLORADO, INC. (AMR) ("CONTRACTOR"), WITNESSETH THAT:

WHEREAS, the COUNTY and the ESA have entered into the original Agreement with the CONTRACTOR on the 1st day of July, 2014; and

WHEREAS, the CONTRACTOR agrees to do, perform, and carry out in a good and professional manner the services as outlined in the original CONTRACT,

NOW, THEREFORE, the parties hereto mutually agree as follows:

The CONTRACT is amended to change the compensation. Per revised Appendix "A" (attached).

COMPENSATION:

This Amendment discontinues the rate controls for the remainder of the contract term. It is agreed to remove the controls on services charges that are charged by AMR. The contract sections that are amended are as follows: Section 3.1, Section 5 and Appendix A sections 8, 12, and 13. All other terms and conditions of the original CONTRACT will remain the same.
